1. Introductions:

The meeting was called to order by Bill Anderson and participants introduced themselves.

2. FY2015 Budget and Work Plan

Kristina Gallant presented a version of the Fiscal Year 2015 budget reflecting the possible inclusion of Arlington.

3. Draft Board and Housing Profile Schedule



Kristina Gallant presented a schedule of all anticipated board meetings and agenda items for 2014. She also presented a draft schedule for completion of the remaining housing profiles, which the group did not object to.

3. AHA Staff Report

Kristina Gallant provided an update on her work since the November meeting. She solicited volunteers to serve as informal technical advisors between board meetings, and Corbitt Loch and Shane Hope volunteered. She also presented a proposal of how to spend the FY2014 "Outside Consultants" funds, which the group did not object to. This proposal included a new GIS license and website for AHA. She reminded the group of her availability for presentations and additional information as requested. Becky Ableman suggested that AHA staff provide an update at the Snohomish County Tomorrow meeting as well.

4. Fiscal Agent Report

Shane Hope updated the group on behalf of the Fiscal Agent, the City of Mountlake Terrace. All jurisdictions but one have paid their FY2014 contributions. A report followed this update via email the next day.
